____ ***Flea Treatment:** Your dog must be treated for fleas with Frontline, Topspot or other Flea/tick prevention. If using natural flea prevention please discuss your methods with us before boarding. If we find fleas on guests they will be bathed at owner's expense of \$100.00

____ ***Core Vaccinations** are required. Core vaccinations vary by age but our requirements are that you have a current Rabies, Bordatella and DHLL/Parvo Virus Vaccinations with proof. Copies of veterinary records can be included with this form or emailed to **emilyrdmccarthy@gmail.com** prior to stay.

____ ***Payment** for first time guests is required at least three days before drop off. We accept cash, check, and credit card. Once payment is made, consider your stay booked.

____ ***Cancellation Policy.** Full amount is refunded if stay is cancelled at least 3 days before stay. If stay is cancelled between 3 days and 24 hours before stay, we will refund half of paid amount. If stay is cancelled within 24 hours of drop off, there will be no refund (this is because we usually have to turn other guests away once we are booked). If it is a special case and there is an emergency let me know and we may be able to work with you.

____ ***Illness or Injury.** Even though we put into place all reasonable precautions and supervise guests at all times, owner is aware that by leaving their dog at a boarding facility, said pet is at a higher risk of injury, contracting canine cough, viruses or other possible injuries. If guest becomes ill or if state of guests health otherwise requires professional attention in our sole discretion, may engage the services of a local veterinarian or provide appropriate medical attention to the animal and any and all expenses thereof shall be paid (or reimbursed) by owner. Owner is aware that there is no medical insurance provided by Comfy Paws.

_____ ***Property Damage.** Owner understands that they are solely responsible for any harm or damage caused by their dog(s) to persons or property, and invitees of Comfy Paws or any other pet(s) housed or visiting.

You release, indemnify, and agree to hold Comfy Paws Boarding and its owners from any and all manner of damages, claims, loss, liabilities, costs or expenses, causes of actions or suits, whatsoever in law or equity, (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by Comfy Paws Boarding. Owner acknowledges and understands that there are certain risks involved in pet ownership, training, and care, including, but not limited to, dog fights, dog bites to humans and/or other pets and the transmission of disease. With owners signature below, he/she understands the risk involved in putting his/her pet in cage-free environment and acknowledge and accept exclusive and sole responsibility for all medical expenses to said pet no matter the cause. Owner also authorizes the release of said pet's medical records from pet's veterinarian. By signing this contract and leaving pet with Comfy Paws Boarding, owner certifies to the accuracy of all information given about the pet. Furthermore, owner has read and understands all procedures and policies included herein. This agreement will be considered current for this and any future boarding for the same dog(s) listed above unless canceled in writing by either party.
